Sub **Introduction of Additional Stream in Provincialized Colleges of Assam  
running with Single Stream**

Sir,

As per decision taken by the Higher Education Department in a meeting held on 15/5/2017, it has been decided to provide and sanction an additional Stream of Study in all the Provincialized Degree Colleges which are running with single stream either having Arts or only Science or Commerce Stream.

The Colleges are required to assess the stream of their choice taking in consideration likely enrolment, availability of avenues of higher studies nearby, requirement, likely availability of faculties having requisite norms etc. The Colleges will take decision on choice of only one Stream and place such proposal in their respective GB and shall send the proposal as per format appended herewith.

While choosing stream the colleges will be careful in regard to likely enrolment, and availability of such stream in nearby areas. It is to be mentioned that while making choice there shall not be any consideration of regularization of teachers already engaged if any. Such consideration shall not influence the choice and decision. All Posts will be filled up by Direct Recruitment only.
