

Sir,

With reference to the subject cited above, I am directed to forward herewith a letter No. HMA-180011/12/12/2017-VIG-H and P/30 (ecf 4980) dtd. 15-05-2017 received from Home & Political Department along with the Minutes of the meeting held on 05-05-2017 chaired by Addl. Chief Secretary, Home & Political Department to discuss the problems of human trafficking in Assam. So far Higher and Technical Education Department is concerned, the following short term & long term measures during the period of drive are suggested with the request to take necessary action for issue of instructions to all colleges accordingly.

- (a) Awarness programmes on rescue and rehabilitation of missing children may be held by involving students of University and Colleges.
- (b) Voluneters may be trained, from Higher Education Institutions on how to identify victims and how to bring perperators to justic, with the assistance from Police Administration, Labour Department, Social Department etc.
- (c) Child Right may be made a part of curriculam.
- (d) Submissioof of report/proposal for consideration of Govt. for giving suitable recognition to any student or student body for their any commendable job on rescue, arrangement for shelter etc. of victims.

Sir,

As you are aware that a large number of children from Assam, have gone missing and many of such children are yet to be recovered. It is apprehended that most of the missing children have been trafficked within and outside Assam. The Govt. has taken this problem very seriously and the matter has been reviewed at the highest level. Although many children have been recovered in past due to good work done by Police, NGOs, Social Welfare Department etc. but it has been felt necessary to launch a month long co-ordinated drive involving stakeholders for achieving better results.

The drive has been named "Operation SUKHI XHOISHOV" and it would be launched on 10<sup>th</sup> of June 2017 for a month in the entire State. The period before launch date would be utilized for preparatory exercise so that the operation is successful. The aim of the operation is to-

- 1) To recover/rescue all missing children from within and outside Assam.
- 2) To rehabilitate the rescued children.
- 3) To provide free medical facility/ counseling to the rescued children.
- 4) To provide legal aid to the rescued children.
- 5) To take strict legal action against the perpetrators of crime as per law.
- 6) To prepare database of the victims and offenders.
