

Sir,

I have the honour to bring to your kind notice that the Bodoland University Act, 2009 was notified in the Assam Gazette vide Notification No. LGL.178/2008/68, dated the 27th February, 2009. The Section 5(2) of the said Act is reproduced below :

"From the date on which this Act comes into force the Gauhati University shall cease to exercise its jurisdiction over all the colleges and institution affiliated to or recognized by it and lying within the to the area of the Bodoland Territorial Council and the Bodoland University shall exercise authority and jurisdiction over them from the aforesaid date, as if they were affiliated to, or recognized by the Bodoland University from the aforesaid date".

In view of the above, you are requested to submit a report to the State Government regarding steps taken by your University to comply with the above provisions of the Act by 31st January, 2017. In case the same has not been complied with till now, You are requested to ensure that it is complied with by 30/01/2017 without fail. A report to that effect may be submitted to the state govt. accordingly.

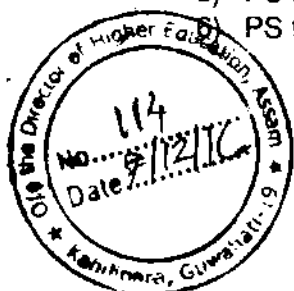
