

Sir,  
With reference to the subject cited above, you might be aware that State Govt. is implementing "Gunotsav" for bringing about improvement in learning level of students at Elementary level. It may be mentioned that Hon'ble Minister, Education, Assam has already announced the implementation of the programme in his budget speech. For this, there will be assessment of performance of children of class-II to VIII along with other areas of schools in the academic year, 2017. The programme will be conducted from 20<sup>th</sup> to 23<sup>rd</sup> March, 2017. The whole State Govt machinery will be involved in the programme. In the 1<sup>st</sup> phase, eight districts viz. Barpeta, Chirang, Dibrugarh, Hailakandi, Kamrup-Metro, Lakhimpur, Morigaon and Karbi Anglong ( West) will be covered under the programme. Hon'ble Chief Minister, Hon'ble Minister, Education, other Ministers, Class I & II officers including IAS, IPS, IFS, ACS officers of the state will be visiting schools as External Evaluator for the assessment. Each External Evaluator will visit 3 schools - one school on each of the three days i.e 21<sup>st</sup>, 22<sup>nd</sup> and 23<sup>rd</sup> March, 2017. They will be spending one full day in the school from Morning Assembly till completion of school evaluation. Their observations and recommendations will be helpful in formulation of policy/designing effective strategy.

As per direction of the Apex Committee, Gunotsav in its meeting held on 22/11/2016, chaired by Hon'ble Minister, Education, Assam cum Chairperson of the committee, faculty of Colleges and Universities are to be involved as External Evaluators in the programme. For this, you are requested to furnish a list of 1000 faculty members from Colleges and Universities from the following districts:
